
A WORD FROM THE CHAIRMAN

MEDESS4MS Meeting, Rome

We are aware that there is a still lot of work to do and we need to further improve oil spill preparedness and response in the Mediterranean region. Listening, exchanging views and ideas, sharing lessons learned and experience are the best way to move forward. We would like to enhance the dialogue with our members and technical partners, invite you to raise us questions and tell us about your needs and expectations, propose new projects and research studies, in brief, help us to make progress because the world is moving and we shall move with it or faster. In this respect, MOIG's main efforts in the future will be focus on enhancing cooperation and information exchange within the MOIG framework, developing and promoting prevention programmes based on innovative approaches and better use of technology, organizing a series of training, courses, exercises and workshops to improve and regularly test regional response capabilities.

For the upcoming two years, we drafted a programme based on the outcome of the meetings of last June 2014 that fully and effectively meet the needs and expectations of our members. The said programme includes training, exercises, workshops and other activities and will be discussed during the forthcoming MOIG MCM scheduled to be held in Tunisia at the end of January 2015. MOIG is also committed to continued progress in the implementation of the MGICAP in cooperation with REMPEC.

MOIG OBJECTIVES

- To promote regional cooperation within the industry and between governments and industry by creating a regional network of industry oil spill response coordinators in all Mediterranean countries.
- To enhance preparedness and response to oil spill incidents in the Mediterranean region by acting as a regional forum for information exchange an discussion on oil spill matters and by making best use of industry resources of equipment and expertise for education and training.

MOIG REGIONAL WORKSHOP

The MOIG Regional Workshop on "Oil Spill Preparedness and Response Partners" was held in Nicosia-Cyprus over 10-11 December 2014. The workshop was organized by the Mediterranean Oil Industry Group (MOIG) in cooperation with IEMS and Shipcon Limassol-Cyprus. The main objectives of the workshop were to enhance communication and expert networking (MOIG Initiative), recognize regional efforts and identify further actions, benefit from Manufacturers and Responders technical expertise, clarify preparedness and response expectations and establish key recommendations. A total twelve (12) speakers from Responders, Manufactures, Cyprus Government, United Nations organization, Public Institutions and Private Companies contributed to this event providing specific presentations. The workshop gathered thirty-nine (39) participants from twenty-two (23) oil companies, responders, manufactures, specialized agencies and associations, governmental and non-governmental organizations, training centre such as ETAP, REMPEC, SAMIR, IEMS, NRC, DESMI, SHELL, SEREPT, TPS, SNDP, SWIRE, TANKMED, CYPRUS OIL&GAS ASSOCIATION, LAMOR, NOBLE ENERGY, FAMELINE OIL & GAS, SHIPCON LIMASSOL, LEVANTINE TRAINING CENTER, DEPARTMENT MERCHANT SHIPPIING, LEMISSOLER NAVIGATION CO, VTTV, SEAHARVEST and SELLENCO.

I would like to take this opportunity to express my sincere thanks to the organizers and in particular the local partner Shipcon-Limassol, IEMS and Seaharvest Group, speakers, MOIG members, guests from Cyprus and MOIG Director for his efforts to coordinate and enhance the MOIG. It was agreed that MOIG will ensure the coordination with the HSEQ Managers in case of Oil Spill, provide technical support through its network of experts in the Mediterranean region in case of need and organize regular Oil Spill Response exercises in cooperation with MOIG.

This agreement confirms the enhancing of cooperation and information exchange among MOIG members. This will build a foundation that we hope will continue to strengthen in the coming years.


